The Town of Cape Charles will hold public hearings on Thursday, March 14, 2019, at 6:30 p.m. at the Cape Charles Civic Center located at 500 Tazewell Avenue to receive comment on:

- A. The vacation of a public right of way on tax map # 90-8-1A2.
- B. The sale of a portion of one lot, located on Marina Road (Tax Map No. 83A3-A-10), to the Hungry Crab, LLC.

This notice is advertised pursuant to § 15.2-2006, § 15.2-1800, and § 15.2-1813 of the Code of Virginia, 1950, as amended. Interested persons may appear at the public hearing and present their views.

These items will be discussed and brought to a vote by the Town Council at the regular meeting scheduled for March 21, 2019.

The Cape Charles Town Council will hold public hearings on Thursday, March 21, 2019 at 6:30 pm in the Cape Charles Civic Center at 500 Tazewell Avenue to receive comment on the following:

- A. An application for a Conditional Use Permit to allow an accessory dwelling unit at 615 Monroe Avenue (tax map# 83A3-1-243B);
- B. Proposed text amendments to the Cape Charles Zoning Ordinance:
 - i. Article IV, Section 4.5.1 adding a mixed-use designation to the Table of Parking Standards, and regulating the minimum offstreet parking requirement for mixed-use development;
 - ii. Article IV, Section 4.5.F.1.k adding a requirement that new mixed-use developments delineate residential parking spaces with appropriate signage.

These items will be discussed and may be brought to a vote by the Town Council at the regular meeting immediately following the public hearings.






With spring approaching and the temperatures warming up, the Public Works Department has issued a reminder asking citizens NOT to rake or blow grass and plant clippings or other yard debris into the streets. Doing so will clog up the storm drains which will lead to flooding that could severely damage personal property. Please do your part to keep the yard debris out of the street by bagging them for proper pick-up.

Please note that our recycler only accepts biodegradable bags. Yard debris placed on the curb in non-biodegradable bags will NOT be picked up. You can arrange for a special pick-up by contacting the Utility Clerk Kathy Fraas at 757-331-6901. Please note that there will be a \$5 per bag charge for this special pick-up.

HISTORIC CAPE CHARLES



Founded in 1886

Cape Charles has one of the best collections of historic buildings of any community on the Eastern Shore. There are many excellent examples of Victorian, Colonial Revival, Craftsman, and Neo-Classical styles of homes in Cape Charles and the Town strives to preserve this rich architectural heritage. In 1997, the Town adopted a Historic Preservation Plan and has recently began the process to up the plan. In 2001, the Town adopted Historic District Guidelines which was revised in 2017. A Historic District Review Board administers the guidelines and oversees new construction and renovations in the Town's Historic District.

HISTORIC DISTRICT REVIEW BOARD

What does the historic district review board do?

The local Historic District is an overlay in the Town's Zoning Ordinance. The purpose of this district is to preserve the designated historic areas, landmarks, and architectural features and to ensure that new construction or alterations are architecturally compatible with the character of the general area in which they are located and with the historic buildings or structures within the historic district. The Historic District Review Board reviews new construction and those actions which are considered substantial alterations to existing buildings. When reviewing applications, the Board refers to the Historic District Guidelines, which can be found on the Town's website. In addition to providing review criteria, the Guidelines are intended to assist property owners who are renovating structures or planning new construction.

Application Procedures

If the Zoning Administrator determines a project requires review by the Historic District Review Board, an application must be submitted to receive a Certificate of Appropriateness from the Board. The application and additional forms can be found on the Town's website on the Planning and Zoning page. Applications must be submitted no later than 14 days prior to the Historic District Review Board meeting to provide ample time for the Zoning Administrator to process the application. After receiving a complete application, the Zoning Administrator prepares a staff report summarizing the nature of the request and making a recommendation of approval or denial to the Board.

The Historic District Review Board holds its meetings on the third Tuesday of each month at 6:00pm in the Cape Charles Civic Center located at 500 Tazewell Avenue. The Board must render a decision within 60 days after the filing of a complete application. If an application is approved, the applicant must wait 30 days before receiving a Certificate of Appropriateness to allow for any appeals. Decisions of the Board may be appealed to the Town Council during this 30-day period. Once the 30-day period is over, the Certificate of Appropriateness may be picked up at Town Hall and work may commence. Prior to commencing work, a property owner must still obtain the necessary zoning clearances and building permits. Denial of an application prevents a property owner from being able to obtain the applicable zoning clearances and building permits.





Yoga for Littles (ages 2 - 5)
